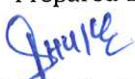

ELIGIBILITY CRITERIA FOR ADMISSIONS

(Session: 2026-27)

1. Introduction

Admission to all the programmes will be made strictly as per the Eligibility Criteria laid down for various programmes.

The Academic Council shall have power to amend or repeal the laid down Eligibility Criteria as per the guidelines of regulating bodies like UGC/BCI/NCTE/COA/PCI/ICAR etc.

2. Eligibility Criteria for Admissions in First Year

2.1 Eligibility Criteria for Undergraduate Programmes

Candidates who are appearing in the 10+2 or equivalent Examination may also apply for Undergraduate Programmes.

2.1.1 B. Tech. {(CE, CS, EC, EE, ME, CS (AI+ML), (DS+AI), EC (EV), EE (EV), ME (EV)} (Duration: 4 Years)

Candidate must have passed 10+2 or equivalent system from any recognized Central/State Board with Physics and Mathematics as compulsory subjects along with one of the Chemistry/Computer Science/Technical Vocational Subject. Candidate must obtained minimum 45% marks or equivalent grade for GEN/OBC and 40% marks or equivalent grade for SC/ST Category in the above subjects taken together.

2.1.2 B. Tech. (Bio-Tech) (Duration: 4 Years)

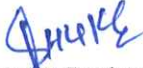
Candidate must have passed 10+2 or equivalent system from any recognized Central/ State Board with Physics and Mathematics/Biology as compulsory subject along with Chemistry/ Biotechnology/ Computer Science/Technical Vocational Subject. Candidate must obtained minimum marks of 45% or equivalent grade for GEN/OBC and 40% marks or equivalent grade for SC/ST Category in the above subjects taken together.

2.1.3 B. Sc. (IT) (Duration: 4 Years)

Candidate must have passed 10th or equivalent system from any recognized Central/ State Board with science as one of the subject and 10+2 in any stream with minimum aggregate marks of 45% or equivalent grade for GEN/OBC and 40% marks or equivalent grade for SC/ST Category.

2.1.4 BCA & BCA (Artificial Intelligence & Machine Learning, Data Science & Artificial Intelligence and Cyber security) (Duration: 4 Years)

Candidate must have passed 10+2 or equivalent system from any

2.1.5 B. Sc. (H) (Physics) (Duration: 4 Years)

Candidate must have passed 10+2 or equivalent system from any recognized Central/ State Board with Physics with minimum aggregate marks of 45% or equivalent grade for GEN/OBC and 40% marks or equivalent grade for SC/ST Category.

2.1.6 B. Sc. (H) (Chemistry) (Duration: 4 Years)

Candidate must have passed 10+2 or equivalent system from any recognized Central/ State Board with Chemistry with minimum aggregate marks of 45% or equivalent grade for GEN/OBC and 40% marks or equivalent grade for SC/ST Category.

2.1.7 B. Sc. (H) (Mathematics) (Duration: 4 Years)

Candidate must have passed 10+2 or equivalent system from any recognized Central/ State Board with Mathematics with minimum aggregate marks of 45% or equivalent grade for GEN/OBC and 40% marks or equivalent grade for SC/ST Category.

2.1.8 B. Sc. (H) (Agriculture) (Duration: 4 Years)

Candidate must have passed 10+2 or equivalent system from any recognized Central/ State Board with Physics and Mathematics/Biology as compulsory subjects along with Chemistry or 10+2 with Agriculture with minimum aggregate marks of 45% or equivalent grade for GEN/OBC and 40% marks or equivalent grade for SC/ST Category.

2.1.9 B. Sc. (H) (Food Technology) (Duration: 4 Years)

Candidate must have passed 10+2 or equivalent system from any recognized Central/ State Board with Physics and Mathematics/ Biology as compulsory subject along with Chemistry/ Biotechnology/ Computer Science with minimum aggregate marks of 45% or equivalent grade for GEN/OBC and 40% marks or equivalent grade for SC/ST Category.

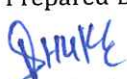
2.1.10 B. Sc. (H) (Microbiology) (Duration: 4 Years)

Candidate must have passed 10+2 or equivalent system from any recognized Central/ State Board with Physics and Mathematics/Biology as compulsory subject along with Chemistry/Biotechnology/Computer Science with minimum aggregate marks of 45% or equivalent grade for GEN/OBC and 40% marks or equivalent grade for SC/ST Category.

2.1.11 B. Sc. (H) (Nutrition & Dietetics) (Duration: 4 Years)

Candidate must have passed 10+2 or equivalent with Biology or Life Sciences as one of the subjects with minimum aggregate marks of 45% or equivalent grade for GEN/OBC and 40% marks or equivalent grade for SC/ST Category.

Operation Theatre Technology (BOTT), Bachelor in Medical Radiologic and Imaging Technology (BMRIT), Bachelor of Optometry (BOPTOM), (Duration: 4/5 Years)

Candidate must have passed 10 + 2 or equivalent system from any recognized Central/State Board Physics, Chemistry, Biology, (Botany + Zoology) subjects with minimum aggregate marks of 45% or equivalent grade for GEN/OBC and 40% marks or equivalent grade for SC/ST category.

2.1.13 Bachelor of Physiotherapy (BPT) (Duration: 4/5 Years)

Candidate must have passed have passed 10 + 2 or equivalent system from any recognized Central/State Board Physics, Chemistry, Biology, (or Botany & Zoology) with 50% aggregate with English Pass. However, in respect of the candidates belonging to Scheduled Castes, Scheduled Tribes, or Other Backward Classes (NCL), the minimum marks obtained in Physics, Chemistry, Biology, are taken together in the qualifying examination shall be 40% marks instead of 50% marks for Unreserved and General-EWS Candidates. In respect of PwBD/PwD candidates the minimum marks in the qualifying examination in Physics, Chemistry, Biology, (or Botany & Zoology) taken together shall be 40% instead of 50% English pass required for all categories. The candidate must have appeared in the National Eligibility Entrance Test (NEET) conducted by National Testing Agency (NTA) for the academic year of the admission. However there shall be no minimum qualifying marks or cut-off percentile requirement for application for the admission. Admission on the basis of NEET Merit/Marks (with no cut-off marks or cut-off percentile for application) of the academic year of the admission. Disability/Physical Fitness criteria as per the curriculum Guidelines.

Candidate must have passed 10+2 or equivalent system from any recognized Central/ State Board with English as compulsory subject with minimum aggregate marks of 45% or equivalent grade for GEN/OBC and 40% marks or equivalent grade for SC/ST Category.

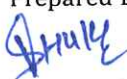

2.1.19 LL.B. (Duration: 4 Years)

Candidate must have passed Graduation from any recognized University or AICTE recognized Institute/ College in any stream with minimum aggregate marks of 45% or equivalent grade for GEN/OBC and 40% marks or equivalent grade for SC/ST Category.

2.1.20 B. A. (J&MC) (Duration: 4 Years)

Candidate must have passed 10+2 or equivalent system from any recognized Central/State Board in any stream with minimum aggregate marks of 45% or equivalent grade for GEN/OBC and 40% marks or equivalent grade for SC/ST Category.

Candidate should have secured pass marks in Maths/ Economics/ Commerce or related subjects.

Candidate must have passed Graduation or Master's Degree in Sciences, Social Sciences, Humanities with minimum aggregate marks of 50% for GEN/OBC and 45% marks for SC/ST or Bachelor in Engineering or

Technology with specialization in Science and Mathematics or any other qualification equivalent thereto from any recognized University or AICTE recognized Institute/ College with minimum aggregate marks of 55% for GEN/OBC and 50% marks for SC/ST Category.

2.1.26 B. Pharm. (Duration: 4 Years)

Candidate shall have passed 10+2 examination conducted by the respective state/central government authorities recognized as equivalent to 10+2 examination by the Association of Indian Universities (AIU) with English as one of the subjects and Physics, Chemistry, Mathematics/ Biology as optional subjects individually with minimum marks of 45% or equivalent grade for GEN/OBC and 40% marks or equivalent grade for SC/ST Category in the above subjects taken together.

"However, the students possessing 10+2 qualification from non-formal and non-class rooms based schooling such as National Institute of Open Schooling; open school systems of States etc. shall not be eligible for admission to B. Pharm. Programme." Any other qualification approved by the Pharmacy Council of India as equivalent to any of the above examinations.

2.2 Eligibility Criteria for Postgraduate Programmes

Candidates who are appearing in the final semester/ year of graduation may also apply for the Post Graduate Programmes.

2.2.1 M. Tech (CE, ME, EC, EE & CS) (Full Time/ Part Time)

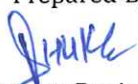
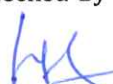
Candidate must have passed B. Tech from any recognized University or AICTE recognized Institute/College with minimum aggregate marks of 50% or 5.5 CGPA for GEN/OBC and 45% marks or 5.0 CGPA for SC/ST Category. Candidate will be offered admission in M. Tech. only in that stream of Engineering in which he has obtained B. Tech.

For M. Tech (Environmental Engineering), candidates must have passed B. Tech (any stream) from any recognized University or AICTE recognized Institute/College with minimum aggregate marks of 50% or 5.5 CGPA for GEN/OBC and 45% marks or 5.0 CGPA for SC/ST Category or M.Sc. (any stream) with 45% marks or 5.0 CGPA for GEN/OBC and 40% marks or 4.5 CGPA for SC/ST Category.

For M. Tech (CS), candidates must have passed MCA/M.Sc.(CS)/MA(CA)/ M.Sc.(IT)/M.Sc. (Electronics)/B. Tech (EC) from any recognized University or AICTE recognized Institute/College with minimum aggregate marks of 50% or 5.5 CGPA for GEN/OBC and 45% marks or 5.0 CGPA for SC/ST Category.

For M. Tech (EC), candidates must have passed M.Sc. (Electronics) from any recognized University or AICTE recognized Institute/College with minimum aggregate marks of 50% or 5.5 CGPA for GEN/OBC and 45% marks or 5.0 CGPA for SC/ST Category.

In addition to the above mentioned basic M. Tech (Regular) eligibility, candidates must have at least 2 years Teaching/Industrial/Research/ Professional Work Experience for 3 years M. Tech (Part Time) in CE, ME, CS, EC & EE.

Candidates must have passed Graduation in Commerce or equivalent from any recognized University/Institute with minimum aggregate marks of 50% or CGPA of 5.5 for GEN/OBC and 45% marks or CGPA of 5.0 for SC/ST Category.

2.2.21 M.Sc. (Economics) (Duration: 2 Yrs)

Candidates must have passed Graduation in Economics or Mathematics stream from any recognized University/Institute with minimum aggregate marks of 50% or CGPA of 5.5 for GEN/OBC and 45% marks or CGPA of 5.0 for SC/ST Category.

2.2.22 M.Sc. (Agronomy) (Duration: 2 Yrs)

Candidates must have passed B.Sc. (H) Agriculture or equivalent from any recognized University/Institute with minimum aggregate marks of 50% or CGPA of 5.5 for GEN/OBC and 45% marks or CGPA of 5.0 for SC/ST Category.

2.2.23 M.Sc. (Soil Science & Agricultural Chemistry) (Duration: 2 Yrs)

Candidates must have passed of B.Sc. (H) Agriculture/Horticulture/Forestry/Chemistry or equivalent from any recognized University/Institute with minimum aggregate marks of 50% or CGPA of 5.5 for GEN/OBC and 45% marks or CGPA of 5.0 for SC/ST Category.

2.2.24 M.Pharm. (Duration: 2 Yrs)

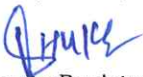
- a) For candidates having not less than 5 years professional experience, after passing B.Pharm. programme, there shall be a relaxation in pass percentage from 55% to 50% for admission to M.Pharm programme.
- b) There shall be reservation of seats for the students belonging to the Scheduled Castes, Scheduled Tribes and Other Backward Classes in accordance with the instructions issued by the Central Government/State Government/Union Territory Administration, as the case may be, from time to time.
- c) For SC/ST candidates the prescribed percentage of marks will be 50% of the maximum marks (aggregate of four years of B.Pharm).
- d) Every student, selected for admission to postgraduate pharmacy programme in any of the pharmacy institution in the country should have obtained Registration with the State Pharmacy Council or should obtain the same within one month from the date of his admission, failing which the admission of the candidate shall be cancelled.

2.3 Eligibility Criteria for Integrated Programmes

Candidates who are appearing in the 10+2 or equivalent Examination may also apply for Integrated Programmes.

In case, the student shows his/her willingness to exit from it, will be allowed to do so in 3rd Year during VI semester by applying on a prescribed format.
- (b) As, the process of integration starts in the Final Year of B. Tech. i.e. in 4th Year. Interested students who are pursuing Regular or Integrated B. Tech. Program with 6.0 CGPA or more till V Semester with no 'F' Grade in any subject have to apply for B. Tech. M. Tech. Integrated Program in a prescribed format in 3rd Year during the VI

Candidate must obtained minimum 45% marks or equivalent grade for GEN/OBC and 40% marks or equivalent grade for SC/ST Category in the above subjects taken together.

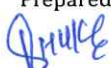
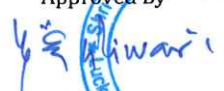

2.4 Eligibility Criteria for Diploma Programmes

Candidates who are appearing in the 10th or equivalent Examination may also apply for UG Diploma Programmes.

2.4.1 Diploma (ME, CE, EE, CS, EC) (Duration: 3 Yrs)

Candidate must have passed 10th or equivalent system from any recognized Central/State Board with minimum aggregate marks of 35% along with Science, Maths & English as compulsory subjects.

2.4.2 Diploma in Pharmacy (D. Pharm.) (Duration: 2 Yrs)

Candidate must have passed 10+2 or equivalent system from any recognized Central/State Board in Science Stream with Physics and Chemistry as compulsory subjects, along with Biology/ Bio-Technology/ Mathematics with minimum marks of 45% or equivalent grade for

GEN/OBC and 40% marks or equivalent grade for SC/ST Category in the above subjects taken together.

2.5 Eligibility Criteria for Ph.D.

A candidate seeking the admission for the degree of Doctor of Philosophy (Ph.D.) in the university must have the following basic eligibility.

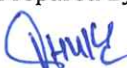
- 2.5.1 Master's degree or a professional degree declared equivalent to the Master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate to its equivalent grade 'B' in the UGC 7 – point scale or an equivalent grade in a point scale or an equivalent degree from a foreign educational Institution accredited by an Assessment and Accredited Agency in its home country shall be eligible for admission to Ph.D. programme.
- 2.5.2 Candidates possessing an M.Phil. Degree or a degree considered to M.Phil. Degree of an Indian Institution, from a Foreign Educational Institution accredited by an Assessment and Accredited Agency in its home country shall be eligible for admission to Ph.D. programme.
- 2.5.3 Candidates who have cleared the M.Phil. Course work in the University with at least 55% marks in aggregate or its equivalent grade 'B' and successfully completing M.Phil. Degree/M.Phil. Dissertation has been evaluated and the viva voice is pending shall be eligible to proceed to do research work leading to the Ph.D. Degree in the University.
- 2.5.4 A relaxation of 5% of marks, from 55% to 50%, or an equivalent relaxation of grade, may be allowed for those belonging to SC/ST/OBC (non- creamy layer)/Differently-Abled/those who had obtained their Master's degree prior to 19th September, 1991 and other categories of candidates as per the decision of the UGC from time to time.

A. Full Time Ph. D.

A student in this category works full-time for his/her Ph.D. degree with or without University fellowship or with project support or fellowship from CSIR/UGC or any other recognized funding agency. The candidate should meet the requisite minimum qualifications for admission to Ph. D programme as mentioned in clause 2.5.1, 2.5.2, 2.5.3 & 2.5.4.

B. Part Time Ph. D.

Institutes and industries, can be admitted on part time basis provided:

- (i) Candidate is working in an organization which encourages and facilitates research
- (ii) Candidate meets the requisite minimum qualification for admission to Ph. D. programme as mentioned in 2.5.1, 2.5.2, 2.5.3 & 2.5.4
- (iii) Candidate fulfills the condition of period of residency
- (iv) Candidate has minimum of one year work experience in the related field
- (v) Candidate furnishes a "consent & no objection certificate" from his/her parent organization.

3. Eligibility Criteria for Admission as Lateral Entry (Second Year)

Candidates may take Admission as Lateral Entry in B. Tech (CE, ME, CE, EC, EE & Bio-Tech), MCA and in UG Diploma (ME, CE, EE, CS & EC).

3.1 B. Tech. {CE, CS, EC, EE, ME} II Year (Lateral Entry) (Duration: 3 Years)

Candidate must have passed 3 year Diploma in the appropriate branch from institutions recognized by AICTE or a State Board of Technical Education or passed B.Sc. degree (with Science) from a recognised University as defined by UGC with minimum aggregate marks of 45% or 5.0 CGPA for GEN/OBC and 40% marks or 4.5 CGPA for SC/ST Category.

3.2 B. Tech. (Bio-Tech) II Year (Lateral Entry) (Duration: 3 Years)

Candidate must have passed 3 Diploma in technical stream from institutions recognized by AICTE or a State Board of Technical Education or B.Sc. degree in Biology/ Microbiology/ Botany/ Zoology/ Chemistry/ Physics/ Maths/ Physiology/ Biotechnology/ Biochemistry/ Agriculture with minimum aggregate marks of 45% or 5.0 CGPA for GEN/OBC and 40% marks or 4.5 CGPA for SC/ST Category.

3.3 B. Pharm. II Year (Lateral Entry) (Duration: 3 Years)

Candidate must have passed 2 year Diploma in Pharmacy from a Pharmacy Council of India (PCI) Approved institution with minimum aggregate marks of 45% or 5.0 CGPA for GEN/OBC and 40% marks or 4.5 CGPA for SC/ST Category.

3.4 Diploma (ME, CE, EE, CS, EC) (Lateral Entry) (Duration: 2 Years)

Candidate must have passed 12th or equivalent system from any recognized Central/State Board with minimum aggregate marks of 35% along with Maths, Physics and English as compulsory subjects.

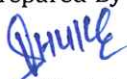
